- 5. Exposure to the elements that may result in frost nip, frost bite, heat exhaustion, heat stroke, sunburn, hypothermia, and dehydration.
- 6. Other dangers of natural elements including, but not limited to, avalanche, rock fall, thunder/lighting, severe and/or varied wind, and other weather conditions.
- 7. Accidents or illness occurring in remote places with no available medical facilities.
- 8. Fatigue, exhaustion, chill, and/or dizziness, which may diminish Student's reaction time and increase accident risk.
- 9. Impact or collision with other athletes, spectators, facility employees, pedestrians, motor vehicles, skateboarders and/or cyclists.
